Presenters will need to deliver informative, educational, and practical presentations matched to audience needs and levels of experience on issues related to risks to health and safety in the mining industry and measures to control those risks.

As a guide, presentations may address the following in a WHS related context:

- lessons learnt from significant incidents,
- practices and/or standards improvement or innovation,
- technology updates, advancement or emergence,
- educational material including practices/standards, general management and mental wellbeing.

- Presentations are typically 20–30 minutes long and may involve co-presenters (please note travel assistance is limited and may not cover co-presenters). Longer presentations may be permitted by approval.
 - PowerPoint slideshows and/or other audio-visual materials such as video and animation are welcome and interactive, case-study based formats are highly encouraged. If you have specific requirements, please advise the team early to ensure the venue can meet your requirements.

Submit an expression of interest

If you are interested in being a presenter, please complete an application form and send it with your attached abstract to rr.workshop@regional.nsw.gov.au no later than 14 days prior to the seminar.

Application process

All written applications will be reviewed by the NSW Resources Regulator's Principal Inspector Mechanical. The individual applications and the overall mix of presentations will be used to determine which applications are successful. The seminar convenor will inform applicants of the outcome of their application via email by 01 August 2023. In some circumstances, a presenter may be notified that their application is successful earlier than this date. If a presentation is unlikely to be accepted, feedback will be provided to the applicant.

If your application to present is not successful, you can appeal the decision by emailing anthony.margetts@regional.nsw.gov.au with the reasons for your appeal.
