5 Additional eligibility for practising certificates to exercise the quarry manager function

The Resources Regulator proposed that holders of the following practising certificates be eligible to apply to have the quarry manager function added:

- a) Mining Engineering Manager of coal mines other than underground
- b) Mining Engineering Manager of underground coal mines
- c) Victorian Quarry Manager certificate of competence.

Outcomes

The board:

- 1. Noted the current eligibility to hold a practising certificate to exercise the function of quarry manager.
- 2. Endorsed the Resources Regulator to gazette that an individual with the following certificates of competence (or the equivalent certificates issued under former legislation) is eligible to be granted a practising certificate to exercise the quarry manager function for:
 - a) Mining Engineering Manager of coal mines other than underground
 - b) Mining Engineering Manager of underground coal mines
 - c) Victorian Quarry Manager certificate of competence.
- 3. Noted that the Resources Regulator will communicate with holders of the practising certificates to advise that they may apply to have the quarry manager function added.

Actions

- G. Resources Regulator to gazette that an individual with the following certificates of competence (or the equivalent certificates issued under former legislation) is eligible to be granted a practising certificate to exercise the quarry manager function for:
 - a) Mining Engineering Manager of coal mines other than underground
 - b) Mining Engineering Manager of underground coal mines
 - c) Victorian Quarry Manager certificate of competence.
- H. Resources Regulator to communicate with holders of the practising certificates referred to in action G to advise that they may apply to have the quarry manager function added.

6 Updated learning from disasters training package

The Resources Regulator and the Australian Centre for Investigation, Incident & Management Solutions (ACIIMS) are updating the case studies used in the learning from disasters training package.

Outcomes

The board:

- 1. Noted the selection of case studies for programs 1–3.
- 2. Noted the 3 packages are now being finalised by ACIIMS for proposed release after completion of the evaluation of the maintenance of competence scheme.

7 Evaluation of the Maintenance of Competence scheme

The discussion paper Evaluation of the practising certificate maintenance of competence scheme requirements was available for public comment on the Resources Regulator's website between 13 November 2023 and 16 February 2024.

Outcomes

The board:

- 1. Considered the preliminary themes that emerged from the on-line survey and written submissions regarding the discussion paper and requested that a follow-up paper be included in the May meeting.
- 2. Noted that the outcomes from the online survey and written submissions (redacted where necessary to de-identify respondents who do not wish to be identified) will be published on the Resources Regulator's web page.

8 Practising certificates issued and certificate of competence exam results report 2018-2023

The trends in the report have not significantly changed. Overall numbers of candidates are trending downwards or remaining low.

Outcomes

The board:

1. Noted the practising certificates issued and certificate of competence exam results report for 2018-2023 and recommended that the Resources Regulator publish information to bring the ongoing low number of candidates to industry attention.

9 Report on maintenance of competence auditing for 2022-2023

206 audit requests were sent to practicing certificate holders in 2023, from which 100 audits were completed.

Outcomes

The board:

- 1. Noted the Report on maintenance of competence auditing 2023 will be published.
- 2. Noted that the Resources Regulator is proposing to conduct 100 audits annually from 2024 to 2026 from a panel of auditing organisations to be procured.
- 3. Requested the Resources Regulator to develop a procedure for addressing audit non-respondents.

10 Outcomes of annual examiner panels meeting 2024

The Resources Regulator held the annual examiner panels meeting on 1 February 2024. Blueprinting will be resumed in full for all rounds of exams for functions in 2024. Dr Bruce Mowbray will commence moderation of all the blueprinted exams (written and oral).

Outcomes

The board:

- 1. Noted the outcomes of the annual examiners panel meeting including that:
 - a. most functions have combined the legislation and practice paper or are considering it from 2024 or later
 - b. panels are considering extending their topics to examine technologies (e.g., autonomous equipment and artificial intelligence) and new legislative requirements around managing psychosocial hazards.

11 Proposal to record oral examinations

The Resources Regulator proposed that oral examinations be recorded to assist with future candidate appeals and moderation of exams.

- 2. Requested the Resources Regulator to monitor appeal requests and present a follow-up paper to the board should evidence arise supporting the need to record oral examinations.
